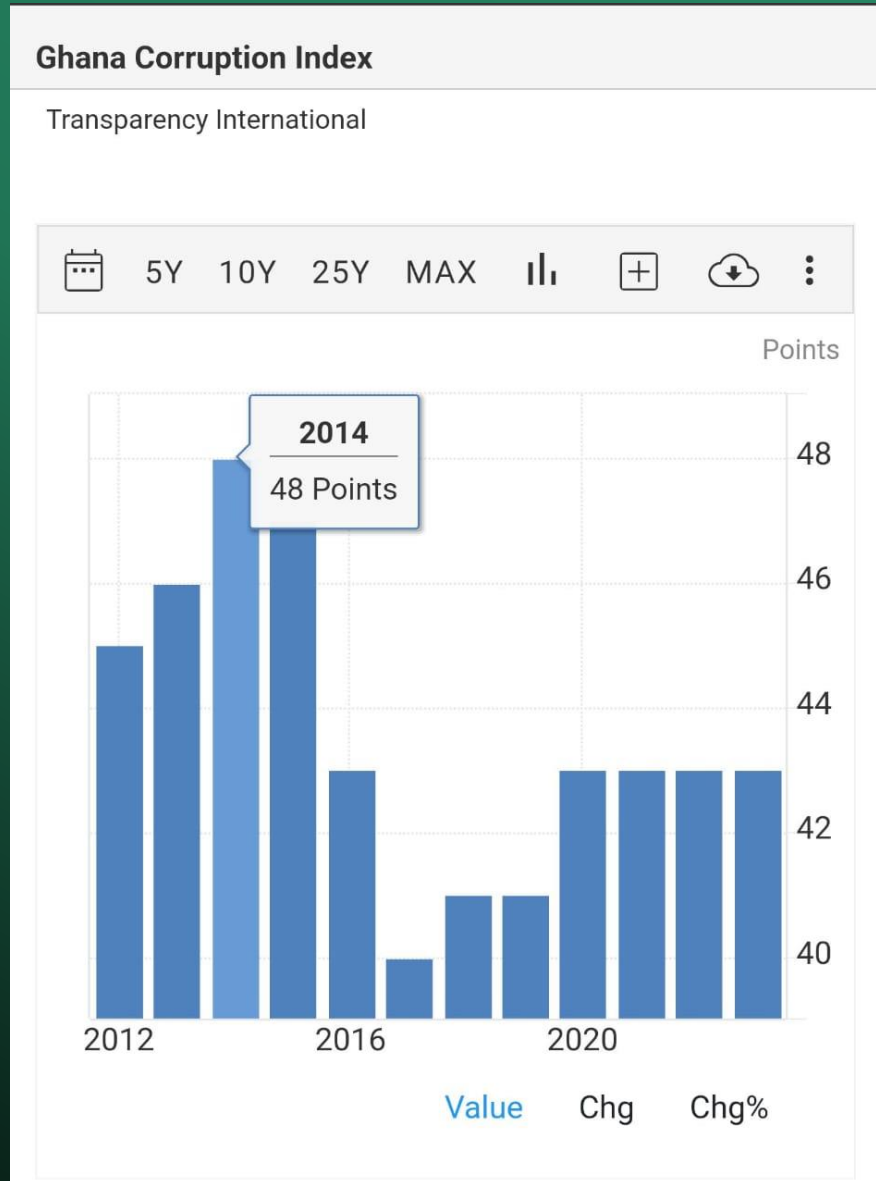

Corruption Index

Ghana's Corruption Perception Index, which peaked at an all-time high of 48 points in 2014, dropped to a low of 40 during the Akufo-Addo-led NPP administration. The Auditor General's report highlights a growing trend of irregularities, further exacerbating the country's corruption perception.

By fostering accountability and improving governance, ORAL seeks to create a stable and trustworthy business environment, reassuring Ghanaians of restoring integrity to public administration.



The Case for ORAL

The Auditor-General's 2023 report indicates significant financial irregularities among public boards, corporations, and statutory institutions to the tune of GH¢8.80 billion.

According to the Auditor General, the majority of these irregularities are considered **RECOVERABLE**, encompassing debts among governmental agencies, overdue receivables, and unretired imprests.

6. Table 1 shows that, the total irregularities stood at GH¢8,799,263,120 which included US\$4,585,776 converted into Ghana Cedis at the prevailing exchange rate of GH¢11.88 to US\$1 as at 31 December 2023.

7. The total irregularities figure of GH¢5,468,398,431 for 2019 increased to GH¢12,856,172,626 in 2020. The irregularities increased by GH¢4,627,310,912 in 2021 to GH¢17,483,483,538. In the year 2022, the total irregularities decreased by 13.9% from the 2021 figure of GH¢17,483,483,538 to GH¢15,059,441,806. During the period ending 31 December 2023, the total irregularities recorded a decrease of 41.6% or GH¢6,260,178,686 from GH¢15,059,441,806 in 2022 to total irregularities figure of GH¢8,799,263,120. Overall, table 2 shows that with the exception of procurement and contract irregularities, all the other irregularity types decreased in 2023 compared with the 2022 financial year even though 135 Institutions were audited and reported on in 2023 compared with the 113 Institutions audited and reported in 2022. It is important to note that the 2023 total irregularities of GH¢8,799,263,120 was made up of a recoverable amount of GH¢8,732,455,124 and administrative infractions figure of GH¢66,807,996. The administrative irregularities were made up of procurement irregularities and other procedural infractions and lapses in public financial management. These administrative irregularities do not connote loss of funds.

8. The recoverable amount constitutes inter-governmental agencies debts, other overdue receivables, locked up investments, unpaid taxes, unretired imprest and advances and loans given to employees of various institutions.

9. The administrative irregularities comprise infractions that arose from procurement irregularities, overdue payables, and the payment of penalties due to delayed payments to suppliers.

GHS25 Billion Banking Sector Clean Up

Between 2017 and 2020, President Akufo-Addo's administration restructured Ghana's banking sector, addressing widespread insolvency and regulatory breaches. The Bank of Ghana revoked licenses of several banks and merged them into entities like Consolidated Bank Ghana to protect depositors and ensure stability. This intervention which was estimated to cost taxpayers some **GHS 12.7 billion** later ballooned into a whopping **GHS25 billion**.



Luxurious Presidential Private Jet Travels

President Akufo-Addo's use of luxury private jets for international travel sparked significant controversy particularly given Ghana's economic challenges and the availability of a functional presidential jet. In spite of government's refusal to disclose detailed information about these travel expenses, citing national security concerns, the substantial costs incurred are estimated to have cost the Ghanaian taxpayer between **GHS 2.8 million** and **GHS 4 million** per trip

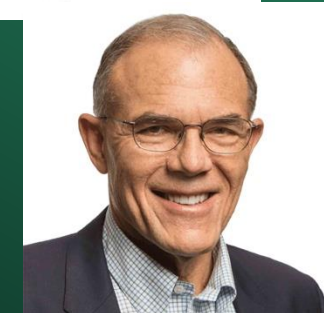

Payment of Salaries to Cathedral Board

On September 30, 2024, three top officials—Dr. Paul Opoku Mensah, Rev. Father Ebenezer Saka Ameyaw, and Mrs. Rebecca Lovia Martechoo Yakpo—were set to receive their September salaries totalling **GHS2.2 million over 31 months**, despite public outrage regarding the project's wastefulness, on a Cathedral Project, which has seen no work since March 2022

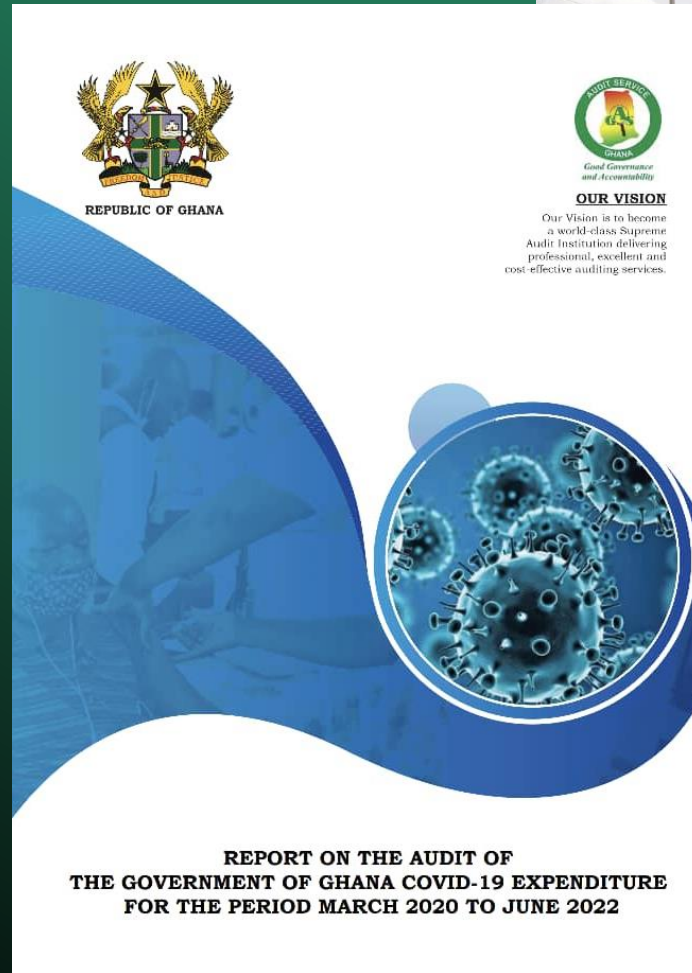
US\$2.8 Million Sputnik V Vaccine Scandal

The Sputnik V vaccine scandal exposed an attempt by the government to procure vaccines at inflated prices, with reports showing a cost of \$19 per dose instead of the expected \$10. However, the vaccines were never delivered. Investigations into intermediaries, including one Sheik Ahmed Dalmook Al Maktoum, revealed even higher pricing, raising concerns about value for taxpayers, the absence of parliamentary oversight, and potential corruption.



GHS21.3 Billion COVID Expenditure

The Akufo-Addo government spent **GHS 21.3 billion** in COVID-19 funds, with the Auditor General's report highlighting several infractions in fund disbursement. These include payments to service providers outside the GIFMIS system, failure to withhold taxes on payments to Smart Infraco Limited, inflated project costs, and other irregularities.



US\$130 Million Frontiers Covid Testing Scandal

The Frontiers COVID-19 Airport Testing scandal implicates the Akufo-Addo Bawumia government in a corrupt contract that prioritized profit over public health. Despite attempts to block information disclosure, documents reveal that:

- Frontiers was chosen without a competitive process.
- Procurement laws were violated.
- Key health institutions were excluded.
- Frontiers charged \$150 per test but the government received only \$10.
- Legal regulatory requirements were ignored.
- The contract allowed for two years of operation regardless of the pandemic's status.
- It is estimated that Frontiers' exploitation earned them over US\$130 million.



GHS250 Million Single-Sourced and Inflated contract awarded to Resource Access Limited belonging to Bawumia's brother

According to the Auditor General's Report, this contract was not only single-sourced but also heavily inflated. Recent findings reveal the company secured substantial payments for various projects including military road rehabilitations, raising concerns about conflict of interest since Bawumia oversaw the Ghana Armed Forces Council.

Based on the documentation submitted, the Committee grants concurrent approval to MOYS to engage the recommended tenderer, Messrs Cisdan Limited at a contract price of **Forty Million, Seven Hundred and Fifty-Five Thousand, Four Hundred and Eighty-Nine Ghana Cedis and Seventy-Six Pesewas (GHC40,755,489.76)** for completion in twelve (12) months.

4. MOYS will now proceed with the remaining procurement processes by giving notice of acceptance, signing a contract within the stipulated periods provided for in Section 65 (1) (2) of Act 663 and (Amendment) Act 914, and keeping records for future procurement audit.

5. Kindly note that failure of MOYS to act in accordance with the above provision shall constitute a breach of the law.

Unconscionable US\$48 Million (GHS602 Million) “Operational Expenses” for the 13TH African Games

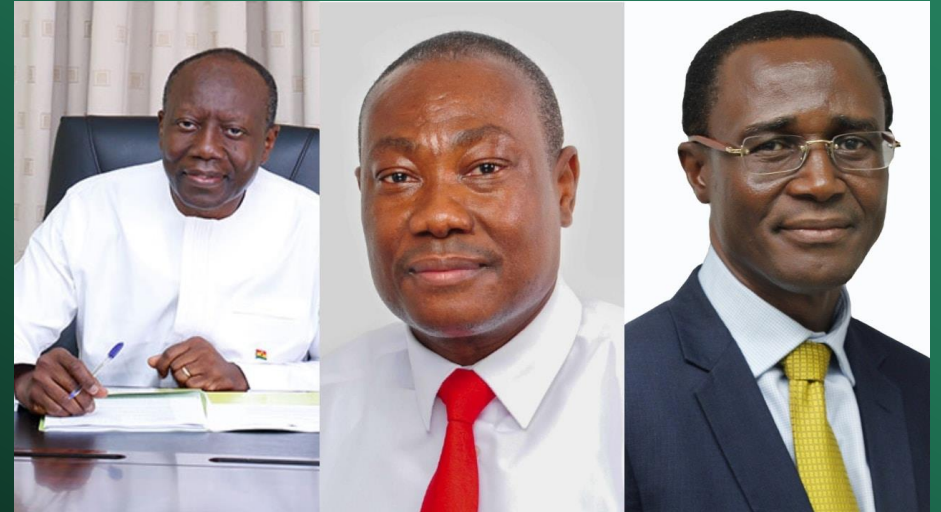

The US\$3 Billion SML SCAM

Investigations revealed that SML, a company with limited prior experience, was awarded a significant revenue assurance contract without proper procurement procedures, including the absence of parliamentary approval. The contract was valued at approximately **\$100 million** annually over ten years. A KPMG audit highlighted irregularities, such as the ineffectiveness of SML's monitoring systems and non-compliance with tax obligations.



Illegal Printing of GHS80 Billion By the Bank of Ghana

Between 2021 and 2022, the Bank of Ghana (BoG) reportedly printed over **GHS80 billion** to finance government expenditure without parliamentary approval, exceeding the legal limit of 5% of the previous year's revenue.

Investigations into the illegal printing by the Bank of Ghana however revealed that **GHC35 billion** was printed in 2021 and **GHC45 billion** in 2022.



GHS95 Million Westblue Scandal

The **GHS95 million West Blue judgement debt**, settled on July 9, 2024, was an agreed consent judgement involving West Blue, the Attorney-General, and the Ghana Revenue Authority. The payment which was scheduled for completion by September 25, 2024, raised concerns regarding the Attorney-General's handling of the case, contrasting with President Akufo-Addo's previous statements on contesting civil litigations against the state.

12. The GoG team indicated that by their computation the Twenty-One Million Six Hundred and Forty-Four Thousand Eight Hundred and Twenty-Six Ghana Cedis, Eighty Pesewas (GH¢21,644,826.80) plus interest translates into Ninety Three Million Six Hundred and Thirteen Thousand Eight Hundred and Seventy Five Ghana Cedis Nineteen Pesewas (GH¢93,613,875.19) as of date.

13. After lengthy deliberations and considering the various scenarios presented by the Parties, the Parties settled on the sum of Ninety-Five Million Ghana Cedis (GH¢95,000,000).

14. The Parties in order to fully settle and resolve all issues in contention, hereby enter into these terms.

B. IT IS HEREBY AGREED AS FOLLOWS;

15. Consent Judgment be and is hereby entered in favour of the Plaintiff against the Defendants for recovery of the sum of Ninety-Five Million Ghana Cedis (GH¢95,000,000) in full and final satisfaction of Plaintiff's claims.

16. The said Ninety-Five Million Ghana Cedis (GH¢95,000,000) shall be paid net of all taxes and payable in 3 tranches as follows:

a. Thirty-Five Million Ghana Cedis (GH¢35,000,000) on or before 25/07/2024

b. Thirty-Five Million Ghana Cedis (GH¢35,000,000) on or before 25/08/2024

c. Twenty-Five Million Ghana Cedis (GH¢25,000,000) on or before 25/09/2024.

d. There shall be no interest on the sum of GH¢95,000,000 during the period within which payment has been agreed to be paid.

17. The Parties hereby mutually Release, Discharge and hold each other harmless from and against any and all liability, disclosed or otherwise flowing from the fee payments of the National Single Window and Integrated Risk Management System ("NSW Contract") subject matter of this suit absolutely.



The US\$12 Million AGYAPA pay off

US\$12 million was spent on the processes to issue the initial public offering of Agyapa Royalties Ltd. on the London Stock Exchange even after the deal fell through. Agyapa was an attempt by the Akufo-Addo led government to transfer Ghana's future mineral royalties to a firm under their control. The deal faced criticism for a lack of transparency, potential undervaluation of assets, and concerns about accountability.





The US\$ 190 Million PDS Scandal

The PDS scandal resulted in the government suspending and ultimately terminating its concession agreement with Power Distribution Services (PDS), a private firm tasked with managing the Electricity Company of Ghana (ECG). The termination was prompted by breaches in payment security provisions by PDS, a company reportedly linked to the Akufo-Addo family. This controversy led to the forfeiture of a \$190 million Millennium Challenge Corporation (MCC) grant intended to bolster Ghana's energy sector. Furthermore, over GHS 1 billion in revenue collected by PDS during its short tenure remains unaccounted for.

USD\$24 Million Pullman Hotel Tax waiver

President Akufo-Addo granted tax waivers totalling approximately **US\$24 million** to a hotel project linked to his brother-in-law, Dr. Kwame Nyantakyi Owusu.

The decision, which was formalized in a letter from the President's office, raised concerns about nepotism and corruption, particularly as it came at a time when Ghanaians were facing increased taxes.

The US\$2 Million failed Skytrain project

In 2019, the Ghana Infrastructure Investment Fund (GIIF) invested \$2 million to acquire shares in a Special Purpose Vehicle (SPV) established in Mauritius to launch sky trains in the Accra metropolis. However, the project was suspended indefinitely, raising concerns about the due diligence conducted before the investment and the subsequent loss of public funds.

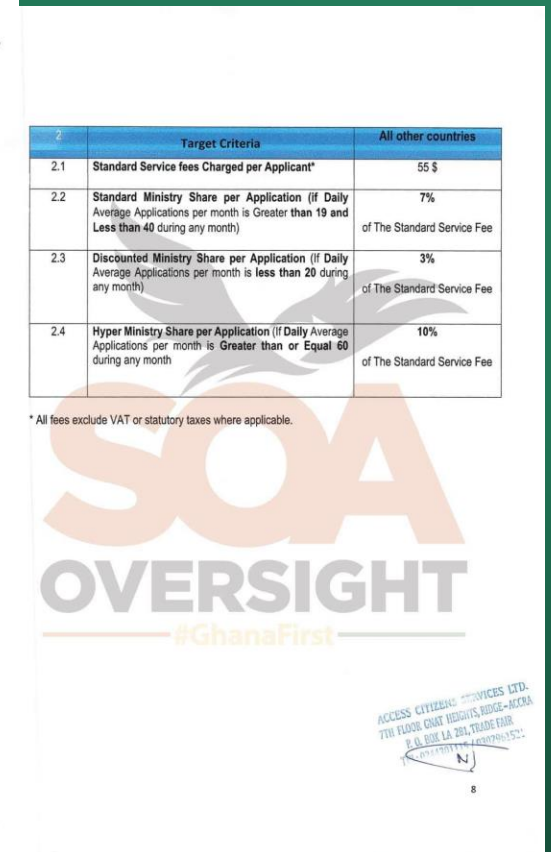
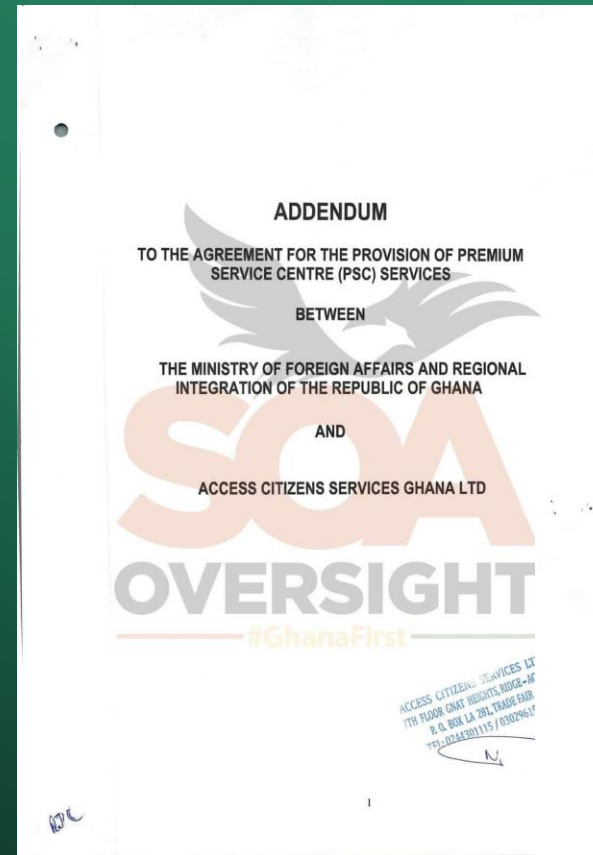

Access Citizens Ghana Limited US\$38.2 Million Visa Processing Scandal

Intercepted internal memos reveal serious worries among top officials at the Ministry of Foreign Affairs regarding the opaque contract with Access Citizens Ghana Limited, including potential legal liabilities, data protection issues, and unfavourable revenue sharing where the Ministry would receive only 2% of proceeds.

There are also concerns about Access Citizens' attempts to impede Ghana's e-visa and visa-on-arrival initiatives and their plans to rent biometric devices from diplomatic missions for only US\$200 a month.



Cecilia Dapaah Scandal

In July 2023, Cecilia Abena Dapaah, Ghana's former Minister for Sanitation and Water Resources, stepped down after it was revealed that significant sums of money—allegedly **\$1 million, €300,000, and several million Ghanaian cedis** were stolen from her home by domestic staff. The discovery of such large, undeclared cash amounts sparked public outrage and prompted her arrest by the Office of the Special Prosecutor (OSP) on suspicion of corruption and related offenses.

Under President Akufo-Addo's direction, the Attorney General advised the Economic and Organised Crime Office (EOCO) to halt money laundering investigations into Dapaah's case, citing insufficient evidence.

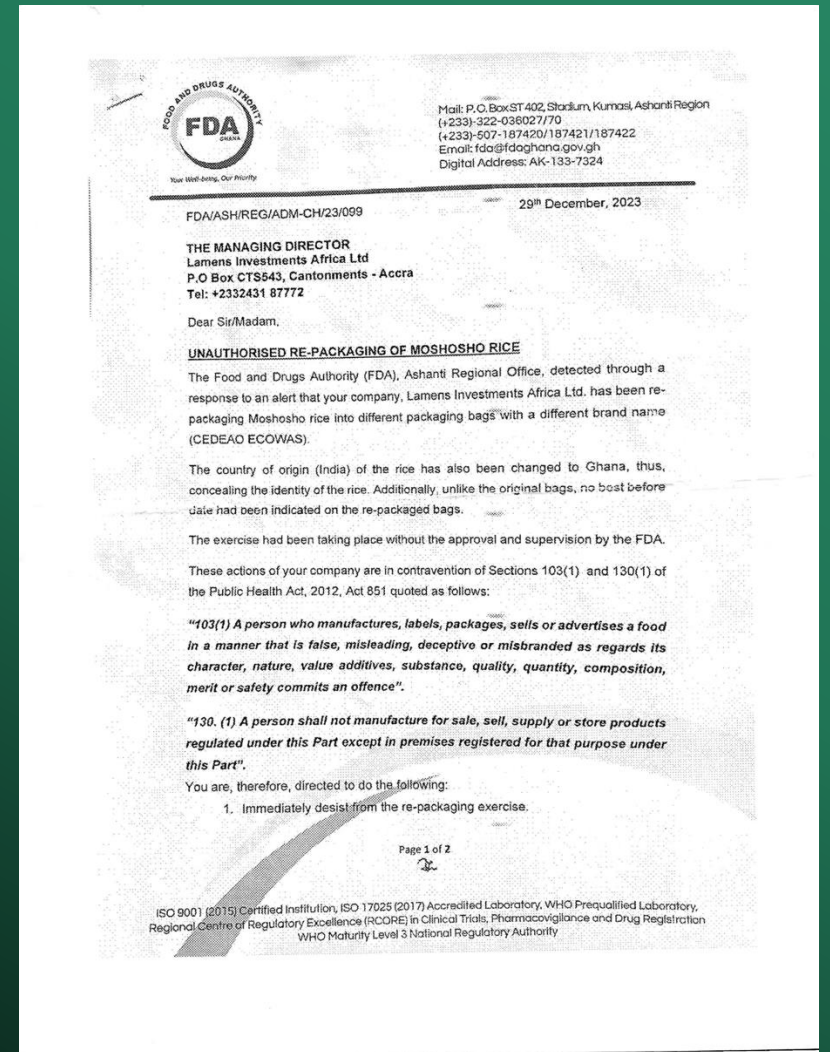
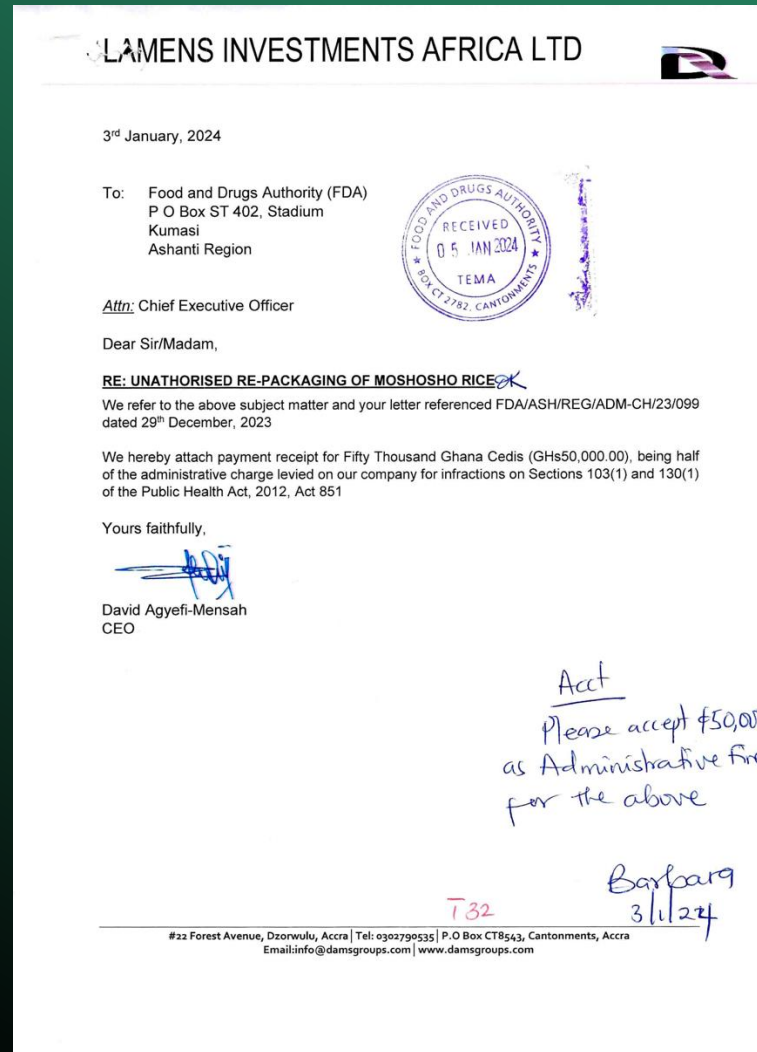

Moshosho Rice Scandal

Approximately 22,000 bags of expired and unwholesome 50kg Moshosho rice, imported from India, and deceitfully re-bagged as "Made-in-Ghana" rice, were distributed to Senior High Schools (SHSs) nationwide.

Consequently, the FDA imposed a **GH¢100,000** fine on Lamens Investments Africa Limited, the company responsible for the violations of which **GHS50,000** has so far been paid.



US\$ 4.5 Billion National Service Payroll Scam

Investigative work by the Fourth Estate revealed the inclusion of over **200,000** fictitious names, commonly referred to as "ghost names," on the National Service Secretariat's payroll between 2020 and 2024. Consequently, this fraudulent activity is estimated to have caused financial losses amounting to approximately **GHS 68.64 billion (around \$4.5 billion)**, if calculated based on a monthly allowance of **GHS 715** per ghost name over 48 months.

The GHS2.6 Billion Dubious, Duplicative Digitalisation Deals in Ghana's Health Sector

The scandal in Ghana's health sector involves dubious and duplicative digitalization contracts awarded without proper procurement processes. Notably, a **GHS245 million** contract was single-sourced to Spectrum Fibre Limited, a company linked to an associate of Vice President Mahamudu Bawumia, raising concerns about conflicts of interest. Critics argue that these contracts overlap with existing projects, such as a **GHS1.3 billion** contract awarded to Lightwave eHealthcare Solutions Limited in 2017, leading to profligate expenditure.

US\$36 Million Covid-19 Smart Workplace Project

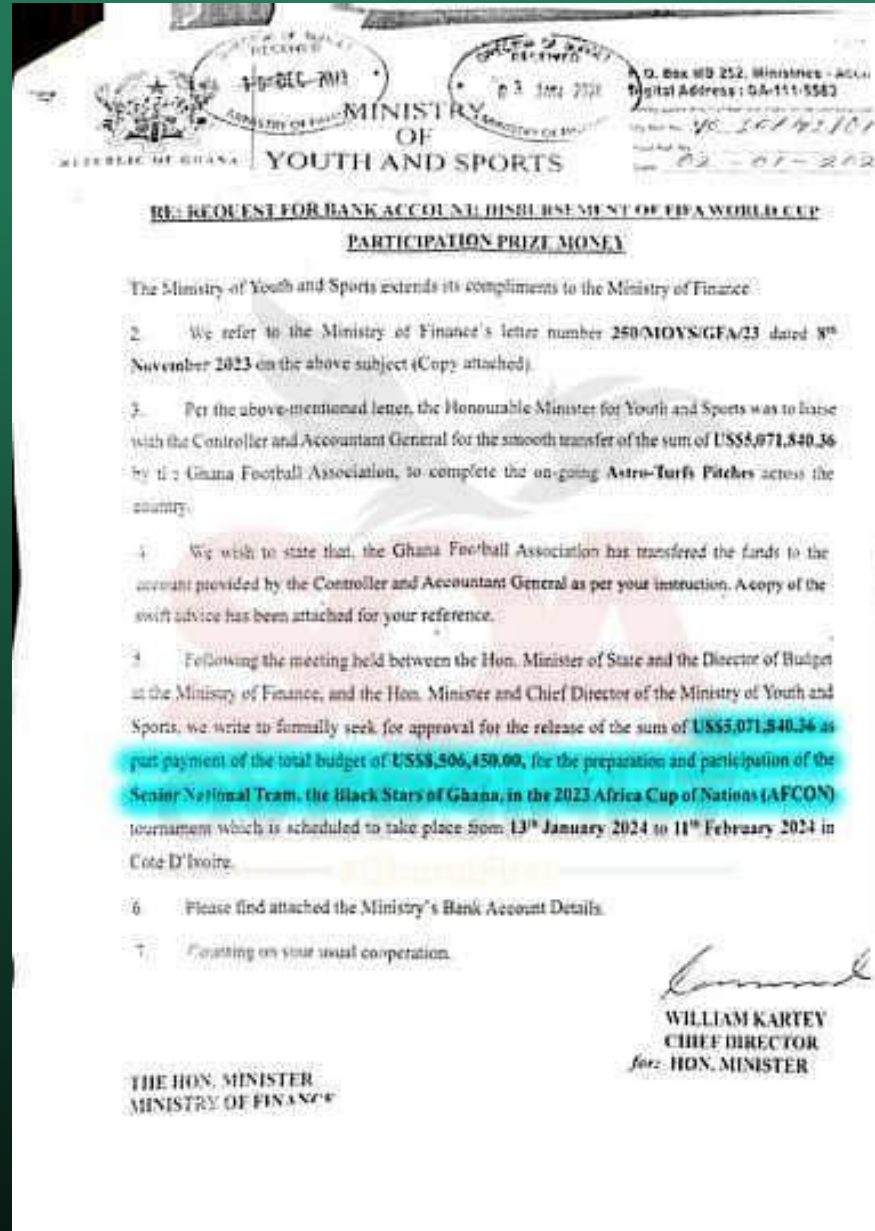
Ken Ofori-Atta faced criticism for not disclosing the cost and details of the government's Smart Workplace Project during his COVID-19 expenditure statement to Parliament. Documents reveal that the project, aimed at enabling virtual work during the pandemic cost Ghanaian taxpayers a staggering **US\$36,061,637.62**—broken down into two payments of **US\$31,596,512.12 in 2020 and US\$4,465,125.50** in 2021. Additionally, an investigation pointed out that the project was approved by the Cabinet for only **US\$8 million**, raising questions about the legality of the procurement process utilized, which was flagged as unauthorized by the Public Procurement Authority.

US\$48 Million Ascend Digital Solutions Deal

This deal is littered with irregularities, misrepresentation, insider dealing & conflict of interest relating to the **US\$48million** Scandal which was used as a cover to fraudulently secure a **US\$49.5million** World Bank funded eTransform project also awarded to Ascend under an AirtelTigo/Ascend JV”.

US\$ 8.5 Million Blackstars Afcon Budget

The scandal exposes government's allocation of **\$8.5 million** for the national football team's participation in the 2023 Africa Cup of Nations (AFCON) in Côte d'Ivoire. This budget, equivalent to approximately **GHS 105 million** at the time, was withdrawn without parliamentary approval.

State Capture

Bulgarian Embassy Demolition

In 2017, the Bulgarian Embassy in Accra, located at Kakramadu Road, East Cantonments, was demolished by a private developer under contentious circumstances. Investigations revealed that the developer, Mr. Jojo Hagan, executed the demolition without adhering to due process, leading to a **GHS5.3 million** compensation and diplomatic tensions between Ghana and Bulgaria.



Bryan Acheampong SSNIT Hotels Scandal/Blay-Brothers and the Labadi Beach Hotel Beach Front Saga

In a clear case of State Capture, the Blay brothers, sons of former NPP National Chairman Freddie Blay, through their company, Express Logistics Limited unlawfully took control of the beachfront, traditionally managed by the state-owned Labadi Beach Hotel, without proper authorization, effectively diminishing the hotel's exclusive access.

- B. Party 1, Party 2, and Party 3 desire to develop, finance, operate and manage the Beach Club permanently on a joint venture basis in accordance with the terms specified in this Agreement.

NOW THEREFORE, THIS AGREEMENT WITNESSES THAT in consideration of the premises and mutual covenants and agreements herein contained and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged by each of the Parties, the Parties covenant and agree as follows:

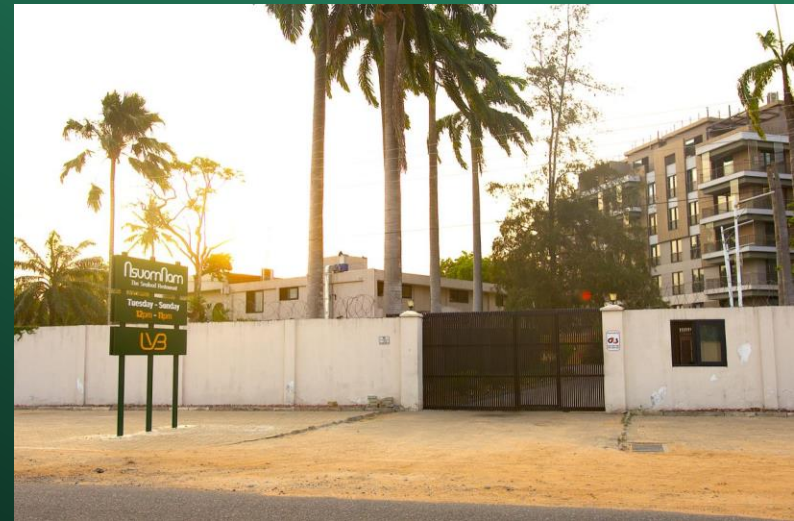

Akufo-Addo Daughter's Nsuomnam Land Grab

The scandal involves conflicting search certificates highlighting issues of transparency and accountability within the Lands Commission regarding the acquisition of land for Nsuomnam, a restaurant owned by President Akufo-Addo's daughter, Edwina Akufo-Addo. This prime land, valued in the millions of US dollars, was reportedly purchased for a paltry sum. The certificates do not clarify how the land was initially acquired, raising suspicions of potential state capture.



Akufo-Addo Niece's Lote Land Grab

This scandal also involves issues of transparency and accountability within the Lands Commission regarding the acquisition of land for The Lote, a fashion Boutique owned by President Akufo-Addo's niece, Adeline Akufo-Addo-Kufuour.

The prime land also located in Cantonments is valued in the millions of US dollars but was also reportedly purchased for a sum far below the market price. Once again, the certificates do not clarify how the land was initially acquired, raising further suspicions of potential state capture by the Akufo-Addo family.



Heaven Builders Land Grab

The scandal exposes a major corruption scheme involving the transfer of prime Airport lands under dubious circumstances to a company backed by powerful figures in government called Heaven Builders Limited,

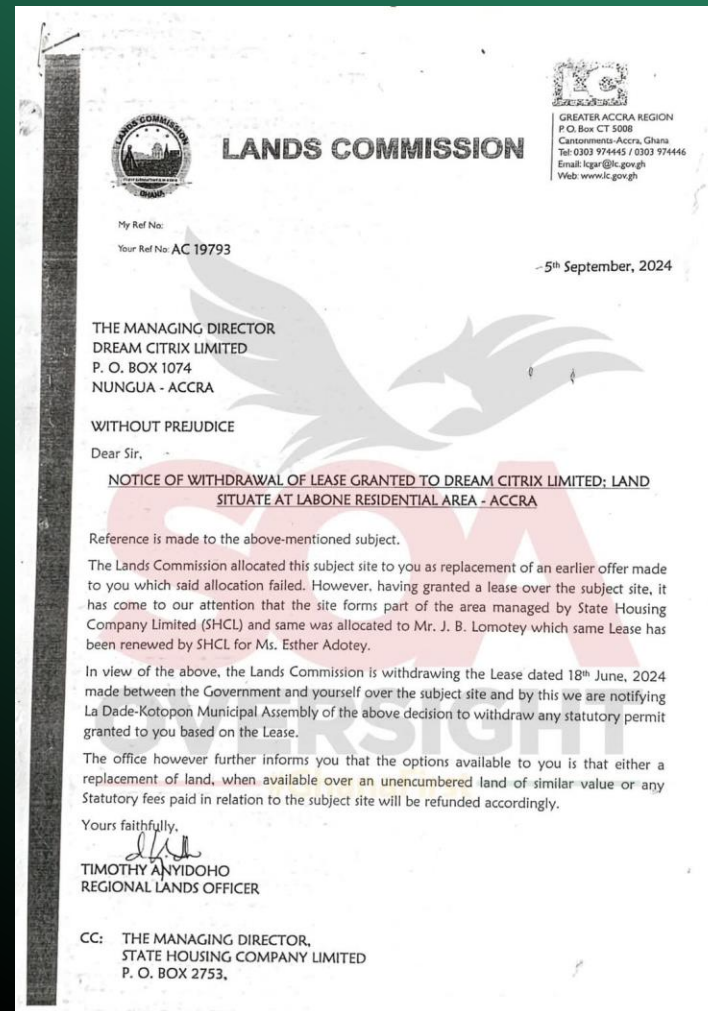

- 1.1 We write with respect to the above subject and to your Offer Letter with reference number GACL/CSD/LRE/22/157 dated December 16, 2022 (the "Offer Letter") in which your company, Ghana Airports Company Limited ("GACL"), made an offer (the "Offer") to Heavens Builders Limited ("Heavens Builders") to be the Anchor Developer ("Anchor Developer") for the Airport City (AC2) project following our Expression of Interest, submission of documents, evaluation and successful selection and further approval of the Project by the Ministry of Finance, Ghana (the "Project").
- 1.2 The Offer requires Heavens Builders to provide the needed infrastructure for Airport City 2 (AC2) in exchange for the grant and or allocation, to us within the Airport City 2, of various parcels of land amounting to the infrastructure cost of US\$85,021,340.00 (Eighty-Five Million, Twenty-One Thousand, Three hundred and Forty United States Dollars).
- 1.3 To our understanding, the object of the Offer is for Heaven Builders Limited to construct, provide and develop infrastructure, such as a road network at its costs, within Airport City 2, Accra, in exchange for 38.14 acres of land which GACL shall allocate, convey, assign, and transfer to Heavens Builders Limited upon the signing of the agreement relating to the Project.
- 2.0 **Response To Terms of the Offer are set out below:**
We have fixed the project cost excluding the contingency at USD 77,435,483.23 therefore a definite land area can be used for the transaction. Please find attached our costing exclusive of the contingency provided.

Lomotey/Adotey Family Land grab

Politically exposed persons involved in this State Capture, in collaboration with the Lands Commission and La Dade-Kotopon Municipal Assembly, demolished a property owned by the Lomotey/Adotey family for over 60 years. An intercepted letter from the Lands Commission admits to mistakenly leasing the land to Dream Citrix Limited, a company with strong political ties. The Lomotey/Adotey family has not received compensation for their losses, and other families in the area have reported similar experiences of political intimidation and exploitation.



Bawumia Aide's Land Grab


Vice President Bawumia's Senior Policy Advisor, Prof. Kwaku Appiah-Adu is unlawfully claiming ownership of land belonging to the Ghana Prisons Service at Roman Ridge. Prof. Appiah-Adu has taken legal action against the Ghana Prisons Service to assert his claims and has reportedly utilized national security operatives to demolish a fence that the Prisons Service built to protect a property, which has been in its possession since 1950.



Parks and Gardens Land Grab (Accra & Wa)

The Lands and Natural Resources Minister confirmed the sale of the Parks and Gardens land in Wa to an Akufo-Addo's appointee. The land was later re-zoned for the construction of a fuel station.

In a similar twist, Dani Ike Estate Developers Limited, led by one Rev. Dr. Ezekiel, encroached upon a 10.8-acre parcel of land belonging to the Department of Parks and Gardens in Cantonments, Accra. This land, allocated in 1952, serves as a vital horticultural nursery and green space within Accra. The developers placed containers on the site and deployed individuals purported to be land guards to assert their claim, leading to confrontations with Parks and Gardens staff.

Reference is made to your letter numbered GC51/145/01 dated June 7, 2021 on the above subject matter, seeking our advice on the way forward with respect to the construction of Five Storey Office Complex for the Ministry of Local Government, Decentralization and Rural Development on the Parks and Gardens' Land at Cantonments, Accra.

Upon collation and review of relevant documentations and thorough investigations of the issues involved, we have made the following observations;

1. That the Ministry has already cleared a site adjacent to the offices of the Department of Parks and Gardens and unfortunately destroyed about one hundred and forty species of trees. This was the initial site meant for the construction of the five-storey office building.
2. That the site plan attached to the application for development permit which is currently before the Assembly is not that of the site which has already been cleared, but rather a new site on the premises of the Department of Parks and Gardens.
3. That the original use of the current site is *Horticultural Nursery* according to the allocation letter issued on 2nd October, 1952 by the Commissioner of Lands (attached as Appendix 1). This is contrary to the Green Civic land use as stated by the Assembly and the Civic/Cultural land use as indicated in the recent allocation letter dated 23rd April 2021, issued by the Lands Commission to the Ministry of Local Government, Decentralization and Rural Development (attached as Appendix 2).

Based on the afore-mentioned observations, we would like to advise the Assembly as follows;

4. That the current site for the Ministry's project is designated as horticultural nursery and, as part of their mandate, the Department of Parks and Gardens uses the land to nurse seedlings and to cultivate other tree species for government and other relevant institutions and the general public for planting and beautification of the city of Accra. The site is, therefore, an active green open space and for that matter a public space and should remain as such.

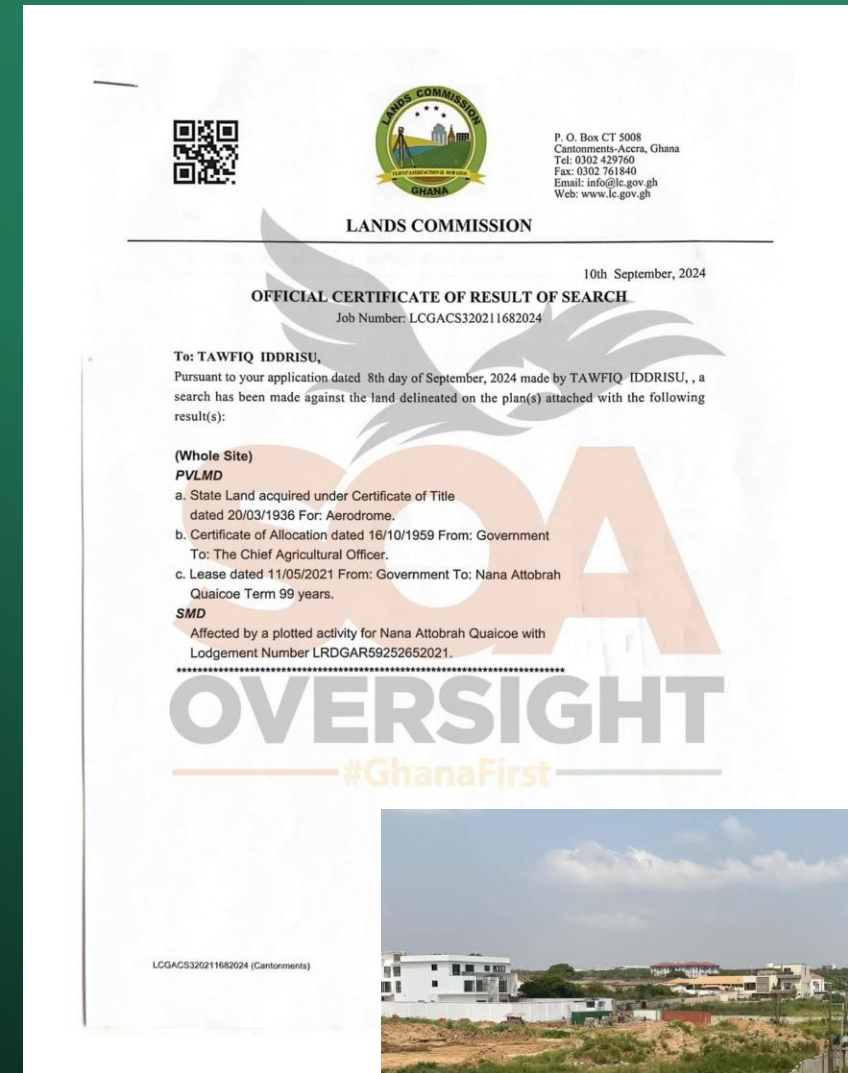
Agric Extension Land Grab

The land in issue was around cantonments was originally acquired by the State under Certificate of Title dated 20th March, 1936 for an Aerodrome. In 1959, the Government of Ghana issued a Certificate of Allocation to the Chief Agriculture Officer.

Curiously, under Ghana's Land Use and Spatial Planning Act, 2016 (Act 925), the re-zoning of public spaces require parliamentary approval, however, the Akufo-Addo/Bawumia government has not requested nor received parliamentary approval for the re-zoning of the Agric Extension Lands which is the latest victim of their mindless land grab.

The land has now been demarcated into 60 parcels and dished out in 99-year leases to President Akufo-Addo's cronies and appointees at ridiculously low prices.

These appointees include Nana Atobrah Cofie and Kennedy Osei Nyarko.



Looting of AU Village Lands in Cantonments

The sales were not publicly advertised and lacked transparency, with significant disparities between the sale prices and market values. Political appointees, including Ministers of State were asked to pay as low as **GHS183,752.00** for a plot compared to a conservative market value of **US\$500,000.00 to US\$600,000.00** per plot.

- **Kwabena Mantey Jectey Nyarko**, an appointee to the board of the Ghana Airport Company Limited by Akufo-Addo, made a 2nd purchase on 20th December, 2022, from the President.
